
"Angsters" is a show formed around two childhood friends who grew up shredding to Suicidal Tendencies and destroying public property. They discovered making full-on art explosions together as a way of combating the suck of suburban poor kid living. Skating, destroying, creating. They grew up and moved on and away from their small-town death trip to the coasts of America. Brothers forever and forever apart. Together in spirit, they decided to come together in person to compare notes and see what they have learned (if anything at all.)


Rick Springer pays homage to the treasure that is trash through marble sculptures and stone masonry. Barbie dolls, Pepsi logos, and cultural detritus infused with a playful sense of irony and casting a critical eye on the objects that end up defining us. Daniel Joseph pays homage to the personal history of a long distance friendship in a corrosive world. Personal letters and photos along with images of serial killers and saints, dead celebrities and storm clouds reworked with scrawls and dots of color. Both have a led different lives based on art damage, Daniel being immersed in the NYC art world, and Rick shunning such trappings by following an active inner life free from the constraints of the gallery system in Northern California. Their aesthetic works so well together because they both started at the same point with similar ideas, thoughts, humor and opinions. An outsider

mentality that bore different fruits from weird trees. As far as they have drifted, they can still meet back up years later with a creative bond made so many years ago discovering and rediscovering what it is that got them to the space they find themselves now.

Angsters is in reference to the dread experienced by living in the ugly wake of this modern age, and within this chaos lies great beauty. Daniel is working on several levels, working with a history both public and private. The dots represent a colorful timeline, a commentary on New Age idealism, as well as a companion to the relentless bombardment of text and images in this era of constant information overload. The gallery walls will be covered with drawings, sketches, notes, photos, text, and various sundry pieces on paper. There will be over 500 new dot paintings on paper.

Rick will be displaying a wide variety of sculptures, all of which are carved out of stone. Rick will be filling the gallery floor with the sculptures he has been working on over the past year. Rick is self taught and obsessive, the sculptures are well thought out and crafted with great care and attention to detail, as well as a wicked sense of humor. The show will take place in an converted barn turned gallery in Bolinas and will be installation based. Together they will form a seamless union formed on true friendship careening towards the end of the world.





A Partial Victory on 'Smart' Meters!

The CPUC voted yesterday 4 to 0 to allow customers to keep their analog meters.

The decision allows individual customers to retain their analog meters or have 'smart' meters replaced with analog meters by paying a one-time fee of \$75 and a monthly fee of \$10, or, for low income customers, \$10 for plus \$5 monthly. Customers who still have the old analog meters have until May 1 to make their decision by visiting this PG&E webpage www.pge.com/smartmeter or by calling 1-866-743-0263. The so-called 'delay list' is now terminated. People who have already been forced to have a 'smart' meter don't seem to have a deadline to respond if they want it removed.

We welcome the opportunity for customers, especially for those already suffering adverse health effects, to be able to get their unwanted 'smart' meters removed and replaced with an analog meter. This is certainly a partial victory for those of us who've protested for so long!

But the decision does not completely solve the problems that EON and so many others have pointed out since the beginning of PG\$E's 'smart' meter rollout.

The wireless 'smart' meter mesh network with 10,000 to 190,000 intense RF pulses of radiation bounced from each household meter 24/7 to other meters throughout the neighborhood, creates a web of radiation that can still harm you, even if you don't have a 'smart' meter on your own home. Depending on where your meter is, your neighbor's meter could possibly affect you even more than your own.

We believe that to force us to pay for NOT putting something on our homes that is a class 2B carcinogen emitter, is extortion. The 'smart' meter emissions are estimated to be hundreds of times higher in whole body RF exposure than cell phones - and they cannot be turned off.

So this is not over. We'll be continuing to work with others towards a more just resolution.

Phase two of the CPUC proceedings on 'smart' meter opt outs that we're official legal participants in, will deal with Community-wide opt out and refine what the real costs to PG&E will be.

CPUC Pres. Peevey says we must pay this fee for meter readers. But we already have costs for meter readers covered in our current rates, so why





Minutes from the December 19, 2011 Bolinas Fire Protection District Board Meeting

Pres. Buchanan called the regular meeting of the Bolinas Fire Protection District to order at 7:30PM. Vice Pres. Kilkenny, Dir. Kimball, Dir. Smith and Dir. O'Donnell were present. Also present: Chief Brown, Secretary Brown and Barbara Kayfetz.

MSC, Kilkenny/Kimball (unan) to approve the agenda.

#### CHIEF'S REPORT

#### Mera

Chief Brown reported that she attended the regular meeting on December 14th. Agenda items included the review and acceptance of the audit FYE6.30.11, action items on several issues such as a Vision Statement, Core Values and Principles of Governance. A motion was approved to move towards a nine member Executive Board that would assume all duties and responsibilities of the current Executive Committee as well as all duties and responsibilities of the full MERA Board, except for approval of the Budget and approval and modification of MERA's indebtedness. The full Board would retain ultimate governance control of the Authority. The proposed Executive Board would include representatives from Marin County, San Rafael, Novato, County Sheriff, Police, Fire, Southern Marin Cities, Ross Valley Cities and Special Districts. Discussion ensued regarding the authority of five out of twenty five member agencies that contribute the most money as to whether they should have a larger role in decision making processes. It was noted that each member agency makes a significant financial contribution relative to their size. Chief Brown has supporting documentation of meeting available to Director's via email. The next regular meeting is scheduled for May 16, 2012.

Pres. Buchanan asked if the Executive Committee can change the bylaws. Chief

Brown answered that the change would require two-thirds of the full membership to pass. He thanked Chief Brown for keeping track of the process of change within the agency.

#### Volunteers

Chief Brown reported that the Volunteers wish to express their appreciation for the holiday dinner on the evening of the 11th.

The Volunteers annual raffle drawing was once again a great success.

The Ford pickup truck to replace U231has been ordered. A quote was received, and with the addition of shipping and taxes, falls within the not to exceed amount of \$30,000 which was approved of at the November meeting.

#### Disaster Council

Chief Brown reported that there is a possible Bolinas Disaster Coordinator candidate from Point Reyes Station which she will pursue.

General Operations/Administration Surfers Overlook Repair/Terrace Avenue: Dir. Kimball reported that SAGE completed their proposal for the next phase of technical engineering necessary for the repair. The proposal includes an estimate of \$47,000 for the geotechnical engineering assessment that does not include the repair design. After meeting with GM Blackman and representatives from SAGE, Dir. Kimball said the proposal was sent to Bob Beaumont at the County of Marin. The County has agreed to continue to fund one half of the cost of work done by SAGE. The source of funding for the other half of the project is yet to be determined. Reconnaissance drilling will commence after the top of Terrace is complete. The permit process for the repair in the North Coast office of the Coastal Commission was discussed but is yet uncertain.

Chief Brown reported that the Maintenance Agreement with CHA will hopefully be completed by February of 2012.

#### GENERAL BUSINESS

Action Item #1: Accept final audit for FY10/11

Dir. Kimball began by reviewing the reason for an audit; to create an overall assessment of a financial system that includes random testing of financials, review of financial statements, evaluating accounting principles and presentations of statements. He was pleased to announce that after meeting with Lisa of Doran and Associates to review the audit, he determined that the BFPD financials indicate a healthy balance between assets and liabilities overall.

Dir. Kimball questioned the depreciation schedule in the Audit which Chief Brown offered to inquire about with Lisa Doran directly. She went on to discuss the management letter that comes with the audit. Most of the recommendations made have already been adopted. One outstanding recommendation yet to be completed is the creation of an employee handbook which Secretary Brown plans to complete in the next fiscal year. The year end bookkeeping is also an issue that needs attention.

Barbara Kayfetz asked if there is a pension offered by the District. Chief Brown answered that the District is not a private industry but is a public government agency that offers membership to CalPERS for full time employees.

Discussion: Emergency only access and egress alternatives to closure of Terrace Avenue and Overlook Road. Chief Brown reported that the top of Terrace is not open yet because PG&E and AT&T need to replace utility poles in the area. She stated that the soccer field is still scheduled for hydro-seeding. She has had some inquires from Mesa Park regarding irrigation of field. She commended the M& G Company for their hard and diligent work on the project.

Dir. Kimball added that a public/private partnership needs to be created in order to finance the repair at Surfers' Overlook once the repair at the top of Terrace is complete. He asked the Fire Board to remind the community how important two access and egress points are during disasters when attending community meetings of any sort. He emphasized the importance of parking enforcement at Surfers' Overlook.

Barbara Kayfetz expressed her concern about disaster preparedness. She said she has served as a Disaster Coordinator for Bolinas for four years in the past and would like to volunteer to help in any way. Chief Brown explained that there are disaster preparedness plans in place that include ongoing training of many volunteers in the community. She offered to contact Barbara about volunteering in the future.

Discussion: Verizon request to add microwave dish to existing Crown Castle tower located on Fire District property. Chief Brown reported that Don Smith has been in contact with Osbourne and Associates researching the 2009 Site Safe report and the current antennae configuration on the tower. Some findings in the 2009 report have been found to be inaccurate. Jennifer Viullemet at County Council has been researching the conditions for modifications requested by Verizon to their current use permit. Chief Brown spoke with Ian Johnson, the District tech support person, who stated that microwave dishes emit less EMF's

than other kinds of antennas on ground level, but a directed beam could increase EMF levels in the second story level of the firehouse. Don Smith hopes to have calculations of EMFs for the proposed modification to the tower ready for the January Board meeting. Everyone thanked Don Smith for his work and identified him as an amazing asset to the Bolinas community.

do we need to pay extra for that service now?

We believe these fees are exorbitant and designed to discourage opt outs.

Community-wide opt out is what we really want. Marin County has a moratorium for the unincorporated county areas, like West Marin. We here in West Marin and Fairfax are the least 'smart' meter installed areas left in PG&E territory. If we have Community wide opt out, like 49 cities and counties in California want, we wouldn't have the mesh network blasting radiation through our neighborhoods, adding to the already high RF radiation from cell towers, wi-fi, cordless phones and other sources.


If you want to keep your old meter, you have until May 1 to notify PG&E or you'll automatically be given a 'smart' meter. You can notify them now, but why begin to pay them extra for keeping what you already have until you must by May 1?


