

Why Giving Presents May Increase Your Happiness

This is the perfect message for Christmas eve. If you have been finding and wrapping presents for your family and friends, read what has just come out in a journal from the Association of Psychological Science. In two studies from the University of Chicago Booth School of Business and Northwestern University Kellogg School of Management, it was found that participants' happiness did not decline, or declined much more slowly if they gave gifts to others rather than repeatedly receiving these same gifts themselves.

Ed O'Brien from the University of Chicago explained – "If you want to sustain happiness over time, past research tells us that we need to take a break from what we are currently consuming and experience something new. Our research reveals that the kind of thing may matter more than assumed. Repeated giving, even in identical ways to identical others may continue to feel relatively fresh and relatively pleasurable the more that we do it."

Here's one experiment they carried out on 96 university students. They were given \$5 every day for five days and required to spend the money on the exact same thing each time. The researchers randomly assigned participants to spend the money either on themselves or on someone else, such as leaving the money in a tip jar at the same café or making an online donation to the same charity every day. The outcome showed a clear pattern. Participants started off with similar levels of self-reported happiness. Those who spent money on themselves reported a steady decline in happiness over the 5-day period. This is called hedonic adaptation. But happiness does not seem to fade for those who gave their money to someone else. The joy from giving for the fifth time in a row was just as strong as it was at the

The researchers suggest that the happiness generated by giving to others helps us maintain our prosocial reputation and reinforces our sense of social connection and belonging.

President's Report: Singing of the mission statement. Agenda & minutes approved. Vote to approve bonuses passed.

Christine reviewed the financial reports and led a general discussion of reports, and the budget. Information included a description of the process. Suggestion was made to have the board members give questions to Susan as Treasurer and she will communicate with accounting. Events are volunteer driven and board needs to remain involved.

Maitreya led a general discussion on measure X and asked * the board to extend input to the county on a position against the measure or express concern of the effect it could have on event attendance. General discussion of the process and next steps for the measure followed. The board decided to maintain an impartiality to political issues.

Manager's Report: A letter of complaint regarding a recent private event was brought to the board's attention and discussed. A general discussion of private vs public events at the BCC followed. History of general procedures and past issues was shared with new manager. The BCC needs new event managers. Kate requested that the board members reach out to anyone they knew who would be interested in training for the paid position. The plaza improvement project was discussed, flagstone has been eliminated as an option due to tripping hazard, and playground rubber was also vetoed. The original plan of building a deck also vetoed due to tripping hazard. The estimates for patterned cement are extremely high. No conclusion drawn.

Treasurer's Report: The process of the board president reviewing the minutes for action items and addressing these as old business was discussed. Susan also brought up old business should be higher on the agenda.

Director's Report: Letters were sent to all Bolinas businesses that were not current business members and there has been some response, current business members continue to renew. Katie Weber, assistant manager, will continue to do special events, event management but will no longer (after the holidays) be an assistant manager with office hours. Randi will cover office hours when Kate cannot be there.

The 2019 budget meeting will be in the office Weds 12/12 at 1:30. A reminder email will be sent out.

Other business: Ayn is resigning from the board due to moving out of Bolinas.

Minutes from the November 19, 2018, Bolinas Fire Protection District Board Meeting

Pres. Kimball called the regular meeting of the Bolinas Fire Protection District to order at 7:00PM. Vice Pres. Chiera, Dir. Gade, and Dir. Shaw were present. Also present: Chief Brown, Administrative Assistant Cadance Lynam, Captain Krakauer, Asst. Chief Marcotte, Nancy Torrey and Stockton Buck.

CHIEF'S REPORT

MERA

Chief Brown attended the October 24th Governing Board meeting. Discussion focused on cash flow and overall funding availability. Currently, the potential change orders could lead to a crash shortage. The Board expressed concern over the cost of the current proposed change orders and the potential for more change orders. They asked for additional time for review of the change orders and requested a review of the project finances. The next meeting is scheduled for November 28th.

The BCPUD Roads Committee and BFPD staff has rescheduled the November 14th meeting to continue discussing moving forward with addressing encroachments into public rights-of-way. Jennifer Blackman and Chief Brown attended the Marin County Board of Supervisors meeting on November 13th where the first reading of the ordinance pertaining to extending enforcement of the Vehicle Code to the non-County maintained and private roads open for public use within Bolinas was heard. The Board did not have any questions and proceeded to set the Merit Hearing for December 4th at 10:30. Every property owner adjacent to the affected roads will receive notice of the hearing. Jennifer and Chief Brown plan on attending.

Training

Recent training has focused on EMT skills, SCBA use, and equipment that is not often utilized. As done every year, we will be taking a break from training beginning the week of December 9th. Training will resume the first week of January 2019.

Apparatus

The new U219 was received. Capt. Krakauer, Asst. Chief Marcotte and Firefighter Grisman traveled to the Ford dealership to finalize the purchase and transport the new 219 and old 219 to the shop where the transfer of the utility box will happen. Once the new 219 is ready, we will bring it back to the station where the electronics will be installed. We don't anticipate it will be in service until sometime in December. In the meantime, U231 is serving as U219.

Disaster Council

Asst. Chief Marcotte and Chief Brown met with a Red Cross representative on October 25th to discuss the current shelter situation in Bolinas and how to improve upon it. Bolinas has four buildings recognized as potential shelters, the Community Center, school, BCPUD building and Commonweal. The discussion included the requirements the Red Cross has for shelter managers. The Red Cross is aware of our designated shelters and the supplies we have stocked in order to open one. Steve will be following up with the Red Cross to solidify new shelter agreements and will be pursuing Shelter Manager training as well as looking at the need for additional supplies.

Chief Brown met with the new school principal several times to review their Emergency Response Plan. Chief Brown attended an all staff meeting on November 1st to review the plan and to walk the campus with the staff and discuss emergency responses to various situations. The school will be holding a large scale earthquake drill on the afternoon of November 15th, which Chief Brown will be observing.

Asst. Chief Marcotte, Capt. Krakauer and Chief Brown met with Tom Jordan from Marin County Office of Emergency Services on the afternoon of October 29th to discuss plans for a Tsunami Drill in town in March of 2019. The objectives of the training will be to help solidify what routes to send evacuees and to test the notification process. Tom reiterated that Alert Marin notifications first go out in text format, if the recipient confirms receipt of the text, no phone call will be placed. If a response is not received to the text, a phone call is placed and then an email message is sent. This led to a discussion about the usefulness of community sirens which Chief Brown will be updating under Agenda Item 4a. MCSO and OES will attend the training. There was discussion of the potential to use the Coast Guard to make beach notifications during a real event. It could be done but would depend upon their availability. Asst. Chief Marcotte and Chief Brown are planning a local CERT recertification class. He has contacted current CERT members to determine their interest in continuing as CERT members, we have heard back from a few saying they are interested in continuing. Chief Brown contacted Maggie Lang, Marin CERT coordinator, to review the required steps to take for recertification and to see if current CERT members can attend part of a larger CERT class in order to be recertified. She is awaiting a response.

Anne Sands, West Marin Disaster Council Coordinator, and Maggie Lang, Marin County CERT coordinator, have announced their plans to retire. Anne will be leaving us at the end of 2018 and Maggie has plans to leave in early 2019. The West Marin agencies will be meeting to review the job description for Anne's position and to determine how to move forward with filling the position.

Capt. Krakauer spoke with a representative from Blue Planet Energy; he was one of the presenters at the Community Microgrid presentation held in Stinson Beach, to collect information about the purchase and installation of batteries as a backup for our emergency power. Capt. Krakauer reported that pricing would primarily be for the hardware since we already have solar panels. The price range could vary between \$50,000 to \$100,000 for each battery. The technology is still new and changing so the price could decrease in the future. The lifespan of a fully charged battery, if being used at full capacity, is one hour; however, they are also recharged by the sun.

Dir. Shaw suggested researching what other local entities do for backup power. We will continue to monitor the evolving technology.

The departments Self Contained Breathing Apparatus (SCBA's) received their annual safety inspection on November 2nd. Everything is in good shape. The annual inspection of the stations fire extinguishers is scheduled for November 16th. Chief Brown will be meeting with Bill Hammett, Hammett and Edison, on November 16th. AT&T has hired them to conduct an RF study on our facility to include the four pre-designated locations as indicated by the 2011 lease amendment. Gratefully, Measure W passed with just shy of 73% in favor. Chief Brown is anticipating the West Marin Chief's will meet early next year to solidify the bylaws which will govern the expenditures for emergency services. The District Finance and Budget Committee will meet to discuss the best uses for the funding and will make a recommendation to the full Board once we have an idea of the amount the District will receive. We are still awaiting the draft audited financials. Chief Brown spoke with the auditor's office recently, they believe they have all of the needed information and will be forwarding the drafts in the near future. Once the drafts are received the Finance and Budget Committee will meet to review them and will present them to the full Board. The rehabilitation of the fuel tank is scheduled for the end of November. The three other participating agencies have been notified of the upcoming work. Work on the solar flashing was recently completed with the total cost coming in less than the estimate including the use of copper.

General Operations/Administration

GENERAL BUSINESS Action Item #1 - Research Purchase and Installation of Emergency Siren -

Dir. Shaw presented research she gathered regarding the purchase and installation of an emergency siren system as an additional method for alerting residents of danger. She highlighted the importance of having multiple ways to reach people in an emergency and reiterated her strong resolve to see a system installed.

The Board and Chief Brown agreed that research on having an emergency siren is a good idea and might be a useful tool to add to the other alerting options. Chief Brown has received several correspondences from residents stating their support for a siren and their willingness to help work on funding for a system. Chief Brown and staff have also been researching emergency siren systems as well as reading reports from various fires regarding what did and didn't work in regards to alerting systems including local and state reports. Chief Brown explained how important it is to have a system that allows for voice messaging rather than a system that simply sounds a siren in order to clearly

explain the emergency and what actions need to be taken. The system must also be remotely accessible due to the Districts inability to guarantee anyone would be available to be at the station to activate the system during an emergency.

The issue of installing a siren system is being researched and considered by almost every jurisdiction in Marin County. The Office of Emergency Services is also taking the issue under consideration as they are receiving many inquiries about sirens. During a meeting with Tom Jordan from OES, he said that OES is not taking a position yet on the instillation of siren systems as they are still studying the pros and cons. Chief Brown believes we need to continue our research as well as speak with other agencies regarding their research on the issue.

Dir. Gade agreed it was a great idea, but that it needed to be refined.

Dir. Chiera also agreed a siren might be a useful tool, however expressed the importance of focusing on wildfire prevention since no system is one hundred percent effective in reaching everyone.

After more discussion, the Board directed staff to continue researching siren systems as well as all systems for alerting residents and visitors during an emergency. The Board requested that this issue be a standing item on each month's agenda. Staff is to bring updates on the issue to each meeting.

Discussion - Proposal from Gunnerson Consulting to Assist the Fire Department in Negotiations with Cell Tower Lease Holders -

Several months ago Chief Brown received a call from a representative of Gunnerson Consulting and Communication Site Services (GGCSS). He stated that they are a company experienced in the cellular communications industry and they assist their customers in negotiations with cellular carriers regarding, among other things, lease negotiations and agreements. In light of our current communications with AT&T regarding their request to modify their communications tower and with the expiration of both leases coming up in 2022, Pres. Kimball and Chief Brown took the opportunity to speak further with GCCSS representatives. GCCSS works with school districts, government agencies,

and property management groups offering guidance and services to landlords of wireless communication sites on the issues they face in managing their wireless carrier tenants and alternative solutions not apparent (or proposed) to the property owner. As a courtesy, GCCSS reviewed the current lease held with AT&T as well as their recent request to modify their tower. GCCSS believes they can be helpful to the process, and have forwarded a Services agreement for consideration by the District. Chief Brown recommended going over the wording of the agreement to make sure we know what we would be agreeing to. She also suggested waiting to hear back from AT&T, since we may not need additional help. After more discussion from the Board it was agreed to continue the discussion and further research of the proposal making it an addition
