## PRELIMINARY HEARING

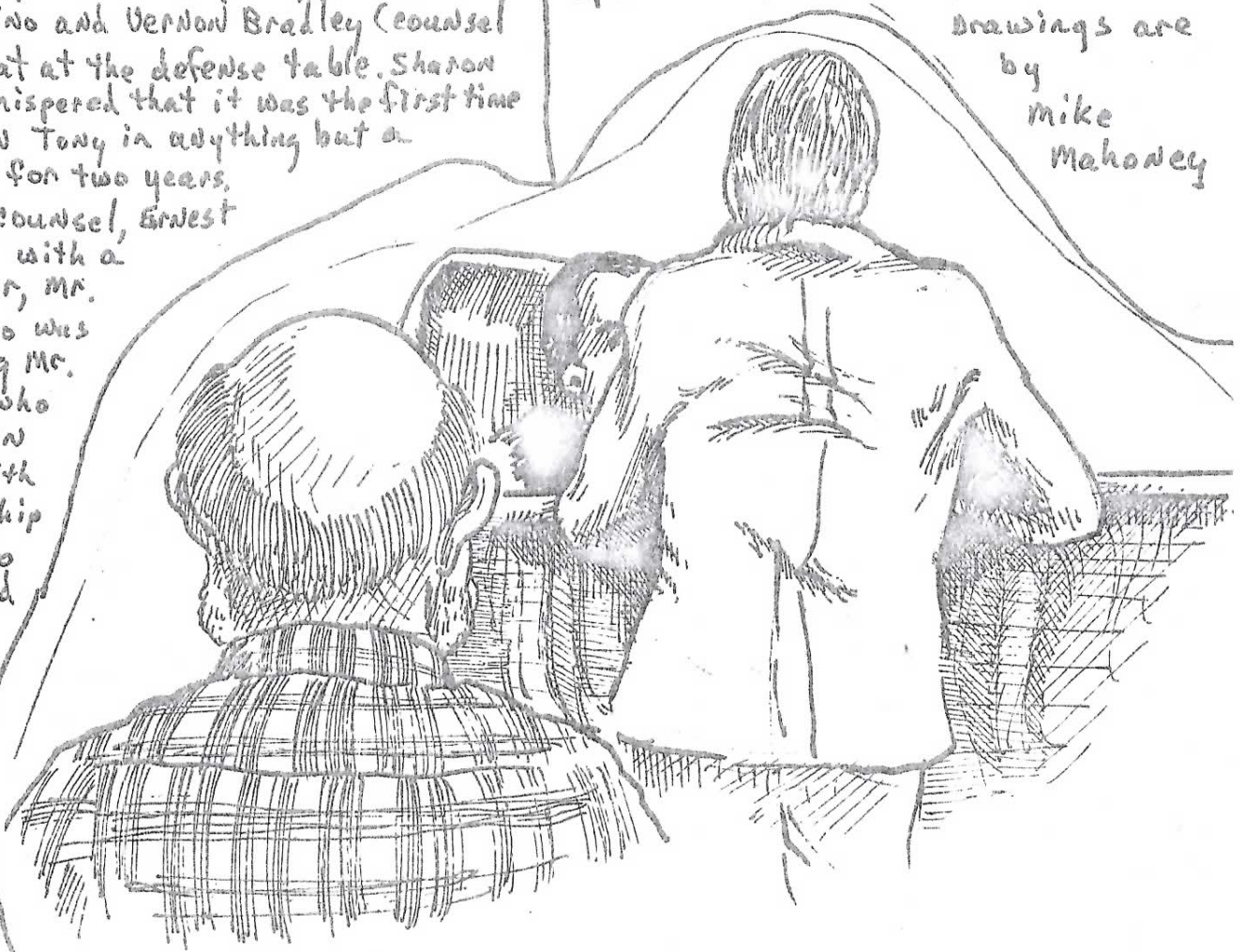

Courtroom #7 is like a space-age theater in the round, we talked in whispers as we waited for the hearing to begin. Judge R. Baty (a familiar face to many traffic offenders who paid for their crimes in Pt. Reyes these past several years) presided. Tony Tarantino and Vernon Bradley (counsel for Tony) sat at the defense table. Sharon O'Onofrio whispered that it was the first time she had seen Tony in anything but a yellow shirt for two years. Prosecution counsel, Ernest Zunino, sat with a young lawyer, Mr. Childress (who was representing Mr. Cardimero, who is involved in some way with a conservatorship that has to do with Tony and his estate). The judge announced, "THE PEOPLE VERSUS LUDWIG TARANTINO,"

And Vernon Bradley rose and asked that spectators be removed from the courtroom "to prevent undue dissemination of information detrimental to my client." The judge said, "are you sure that's what you want?" and then Mr. Bradley, Mr. Zunino, and Judge Baty held a whispered conference at the bench. They decided to invoke sections 867 and 868 of the Penal Code, but also decided to make an exception for Mr. Childress because of, as Judge Baty said, "the extensive financial ramifications of a conservatorship." Mr. Bradley appointed Mr. Childress his assistant, and then the courtroom was cleared. At this time the Hearsay News knows nothing more, except that a gag rule has been imposed on all witnesses, forbidding them to disclose details of the case. We hope to attend the trial and report it in full, but as of yet, we don't know when it'll be, or whether it'll be open to spectators.
